REGISTRATION POLICY

Applicable to enrolment of piano, guitar, violin lessons and music theory courses

1. **Registration Form:**
 - a. A complete registration form must be filled out correctly.
 - b. For students under 15, parents or guardian signature is necessary.
 - c. A non-refundable \$25.00 registration fee is applied to new student registration.
 - d. Siblings of Euromusic students will receive a \$10.00 registration discount when enrolling with us.
2. **Applicable Administrative Fees**
 - a. Late payment fee (after 15th of each month) 2% interest per month charge on past due amount
 - b. Withdrawal fee \$50.00 per student
 - c. Returned cheque charge (NSF, Stopped payment) \$25.00 per cheque
 - d. Re-issue receipt \$20.00 per issue
 - e. Transfer Fee (for theory classes) \$40.00 (after commencement of theory classes)
3. **Withdrawal and Refund:**
 - a. *Withdrawal and Refund request* must be submitted in writing to our office.
 - b. A one month's notice must be given to our office prior to termination of lessons.
 - c. No withdrawal fee will be applied to students (piano, guitar & violin) who have studied with us for more than one year.
 - d. Allow 3 – 5 weeks for processing.
 - e. The following rules apply to **theory class students**:
 - *Withdraw before the first scheduled class* - \$50.00 withdrawal fee will be deducted.
 - *Withdraw before the fourth scheduled class* - \$50.00 withdrawal fee plus number of sessions attended will be charged.
 - *No refund will be made after more than three scheduled classes have been attended.*
4. **Bonus Programme for Theory Students:**

If your first RCM written examination is unsuccessful, you may qualify for a one-time free course under the following stipulations:

 - a. Only when a vacancy in that class is available.
 - b. You must study under the same teacher within one year.
 - c. You must have completed all required assignment and homework in the previous term.
 - d. You must not have missed more than 2 lessons in the previous term.
5. **Fee Payment:**
 - a) Personal cheque, cash or direct payment are acceptable as method of payment.
 - b) A 5% service charge will be applied to Credit Card payments.
 - c) Make cheque payable to "EUROMUSIC" with student name and subject printed on it.
 - d) A 2% interest charge per month will be applied to past due tuition fees.
 - e) **Postdated cheques are not accepted for enrolment of theory courses.**
6. **Examination Application:** Our Euromusic Teacher's Number is **26362**
 - a. *On line*: - Piano candidates may choose their own date and time and may change their schedule as availability permits up to the application deadline. Examination timeslots are available on a first-come-first-serve basis.
 - b. *By Fax or Mail*: - Paper handling fee will be charged by RCME.
7. **Lesson Cancellation: (private lessons only)**

It is our primary goal to provide students with music education of the highest level we can offer, and to give parents a sense of satisfaction that meets their expectations. In order to better utilize our resources to serve the motivated and committed and maintain the high standards of music education you have come to expect, we ask you to observe the following terms of our studio policy:-

 - a) **No allowance will be made for lessons missed by students.** (except for special arrangement due to prolonged illnesses or lengthy vacation). Students must assume the responsibility of cancelled lessons. Please limit your cancellations to emergencies. A minimum 24-hour notice is required for lesson cancellation; otherwise lesson may be charged at the teacher's discretion.
 - b) In the event of teacher's absence, future adjustments will be made.
 - c) Time lost as a result of student's lateness will not be made up.
